


MESSAGE





BluSmart will soon be adding EV cabs. It recently signed an agreement for supply of EVs. With a focus on creating charging infrastructure, BluSmart also recently announced a strategic partnership to set up a network of EV charging stations across the country starting from Delhi NCR.

Torchit has also gained support from multiple platforms including being appreciated by our Honourable PM Shri Narendra Modi.

Torchit intends to cover the entire blind/visually impaired population in India and the rest of world, especially in rural and tribal areas by providing technology to the last mile population.

TorchIt has also designed another product called Jyoti, an end to end tech device for the blind/visually impaired.
